Vigilance needed to fight COVID

We're certainly receiving the clear message that, again, our Mallee communities will not be isolated from the rising COVID-19 infection numbers across the State.

COVID-19 is circulating in our Mallee communities - with the number of reported cases up by 67 per cent - and all of us have a critical role to play in increasing our vigilance and attention to COVID-safe practices. They have kept us safe previously, and it will be our actions every day that keep ourselves and others safe this time.

All staff, volunteers, contractors and visitors need to wear an N95 mask while on site at MTHCS. There are very few exemptions - outdoor staff (while outdoors) and kitchen staff (while in the kitchen) are the notable exceptions. The only other reason not to wear an N95 is if you have a medical exemption and if you do, please ensure this is provided. If you need to remove your mask to eat, please ensure you practice social distancing.

Also, we are again urging people who work at or visit our facilities to take precautions when in the community. One way to minimise your risk of catching COVID is to wear a mask when indoors at places such as the supermarket.
